THE JURIED ARTIST MUST HAND CRAFT ALL WORK. To the best of our ability, we try to insure that all merchandise is hand made by our vendors. Therefore, we ask your cooperation by not bringing any product that you did not make yourself.

IF YOU DID NOT MAKE IT, DO NOT BRING IT. PLEASE LEAVE YOUR WHOLESALE ITEMS AT HOME. For any questions you may have about handmade items, please call or email us with your questions.

We strive to maintain a highest quality show, with products that are handmade with pride by the vendors.

PLEASE DO NOT SEND BOOTH FEES WITH THIS JURY APPLICATION.

If you are accepted as a vendor, you will sent a contract. At that time, you will return the completed contract indicating your choice of booth space and your booth fees. We do comprehensive advertising in newspapers, radio, television, social media and national magazines. If you are accepted we will provide you with postcards to distribute at your other shows and in your community.

Please fill out the attached application and submit with 5-7 **quality photos of your work and 2 of your booth. NO slides, CDs, DVDs, or merchandise will be accepted. The Jury committee meets as a group and does not have access to equipment to look at anything other than photos.** Please include 3-4 pictures of your work in progress. Close-up photos of your work enables the jury committee to select the highest quality crafts.

Remember: Photos speak for you as they are presented to the committee.

A \$5 jury fee is required. Please make your check payable to Illinois Heartland Decorative Artists (IHDA) and forward it along with your photos and application of:
